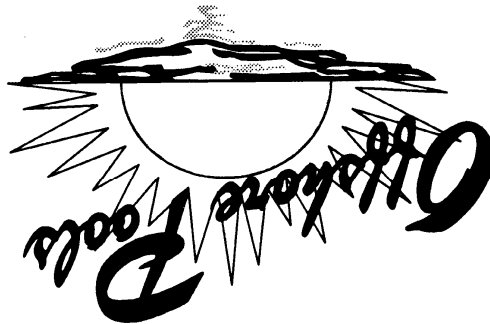

## Homeowner's Responsibilities

- Homeowner must have all winter items poolside i.e.: Cover, cover bag, blow out tubes, plugs, and any other winterization items necessary.
- If you have a winter safety cover with ANY type of drainage, you must lower your water level to 6-8" below the bottom of your skimmer by way of main drain on backwash. You MUST CLOSE OFF ALL VALVES EXCEPT THE MAIN DRAIN VALVE to insure that the water goes all the way down.  
**\*POOLS WITH WATER BAG COVERS AND COVERS THAT REQUIRE YOU TO PUMP WATER OFF OF DURING THE WINTER, DO NOT NEED TO LOWER THEIR WATER LEVEL**
- Please leave a check in a Ziplock baggie taped to the filter and the filter only. If there is no check, we will put the balance on the cc you left for deposit. If there is no cc on file, we will not be able to close your pool and there will be a \$35.00 return trip fee.

**NOTE: ALL POOL EQUIPMENT REMOVED WILL BE LEFT POOL SIDE FOR HOMEOWNER TO STORE.**

**NOTICE:: MAKE SURE TO TAKE OUT YOUR TIMER CLIPS SO THAT THE FILTER DOES NOT KICK ON THE NEXT MORNING. DETACH AND SEND BOTTOM PORTION IN WITH YOUR DEPOSIT AND KEEP TOP PORTION FOR YOUR INSTRUCTIONS**

**\*Offshore Pools must complete at least, a plumbing closing EVERY YEAR consecutively, in order to keep the lifetime warranty on the pool lines.**

**SAND FILTERS DO NOT REQUIRE FILTER CLEANING (A SAND CHANGE IS SUGGESTED EVERY 5-7 YEARS)**

*A filter cleaning is needed at every closing so that your pool, when opened in the spring, is clean and ready to go. We do not offer a filter cleaning as part of a pool opening and if ordered in the spring, will be at a much higher service call rate.*
