## POOL MAINTENANCE AGREEMENT

- One trip per week (additional trips can be arranged)
- Net debris off the top of the water
- Clean all baskets.
- Vacuum entire pool/spa.
- Test total water chemistry balance including 6 parameters.
- Make chemical adjustments for the week.
- Maintain filter system when needed.
- Inspect system, pool and yard for safety hazards and preventative maintenance.

INITIAL CLEAN-UP CHARGES ARE AN ADDITIONAL FEE TO GET THE POOL READY FOR WEEKLY MAINTENANCE.

WEEKLY SERVICE CONTRACTS ARE AT MINIMUM 16 WEEKS. **(CHEMICALS ARE NOT INCLUDED IN THE COST) CREDIT CARD IS REQUIRED FOR ANY ADDITIONAL WEEKLY CHARGES.**

FOR SPAS NOT ATTACHED TO POOLS, \$40.00 ADDITIONAL WILL BE BILLED

UP TO 1 HOUR IS INCLUDED IN THE MAINTENANCE RATE. ADDITIONAL TIME IS CHARGED 85.00 PER ½ HOUR.

ALL SERVICES MUST BE PRE-PAID. THERE ARE THREE OPTIONS AVAILABLE.

16 WEEKS PRE-PAID WOULD BE  $16 \times \$125.00 = \$2000.00 + \text{TAX} + \$2,132.50$

PRE-PAID MONTHLY FOR 16 WEEKS =  $4 \times \$140.00 = \$560.00 + \$597.10$

BI-WEEKLY IS AVAILABLE \$150.00 PER SERVICE MIN. OF 8 WEEKS  
= $\$1200.00 + \text{TAX} = \$1,279.50$
